MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objectives and Strategies

The investment objective of the Educators Monitored Growth Portfolio (the “Fund”) is to provide potential for long-term capital growth with low to moderate income. It does this by maintaining a balance of investments across several asset classes. The Fund invests primarily in mutual funds that invest in securities of Canadian and foreign governments and corporations. The asset mix is varied depending on the outlook for the economy and financial markets. The fundamental investment objective of the Fund may not be changed without the prior approval of the unitholders.

Risk

The risks of investing in the Fund remain as discussed in the Simplified Prospectus. Since inception of the Fund no changes affecting the overall level of risk of investing in the Fund were made to the Fund as at December 31, 2023.

Results of Operations

The Fund’s net assets increased by 8.1% to \$18.7 million at the end of December 2023, up from \$17.3 million at the end of December 2022.

Investment Performance

For the year/period ending December 31, 2023 (the period), the Educators Monitored Growth Portfolio – Class A Series provided a return of 12.66% versus a Benchmark return of 13.73%. The Benchmark is a weighted composite consisting of 20.0% MSCI EAFE Index C\$, 25.0% S&P 500 Index C\$, 30.0% S&P/TSX Composite Index, 22.5% FTSE Canada Universe Bond Index, and 2.5% FTSE Canada Short Term Bond Index (the Benchmark).

The Fund underperformed its blended Benchmark over the period. Unlike the Benchmark, the Fund’s return is net of fees and expenses paid by the Fund. Detailed performance is provided under the heading “Past Performance” in this report. Investors cannot invest in the Benchmark without incurring fees, expenses and commissions which are not reflected in Benchmark returns.

Markets rallied in 2023 despite continued recessionary fears, hawkish monetary policy, and the first quarter’s banking crisis. The period also began and ended with strong performance in fixed income markets. While several vulnerable U.S. regional banks and Swiss banking giant Credit Suisse were caught up in the early year turmoil, well-capitalized developed market banking systems and policymakers’ timely interventions prevented issues from spreading. Following these events, Canadian and International markets generally traded sideways in a wide range with mixed sentiment until expectations of central bank rate cuts powered an impressive rally during the final two months of 2023. In comparison, U.S. equities roared past peers amidst resilient earnings and speculative interest in a narrow group of large cap stocks linked to Artificial Intelligence.

Domestically, the Bank of Canada (“BoC”) increased its Benchmark overnight interest rate by 0.75%, leaving the overnight rate at 5.00% at year-end, adding to tight financial conditions that muted Canadian economic growth and equity returns. This shifted in late-2023 when equity markets experienced a sustained and rapid rise across almost all sectors as the prospect of a soft-landing and an end to rising rates ignited optimism. All told, the strongest performing domestic equity sectors in 2023 were Information Technology, Health Care, and Financials. Materials, Utilities and Communication Services were the biggest laggards.

The Portfolio closed out 2023 on a high note, finishing with strong absolute returns. Security selection contributed to performance, while asset allocation had a modestly negative impact.

Key contributors from security selection included solid results from fulfilments in Canadian growth equities, international equities, and Canadian core bonds. Regarding international equities, a tilt towards information technology as well as strong performances from secular growth companies in the two consumer sectors and health care drove returns. Meanwhile, overall asset allocation from investments in global high-yield bonds and emerging market debt, which were bolstered by positive global economic and earnings surprises throughout the year. Lower-than-benchmark weight to overall fixed income also helped since government bonds and higher-grade corporate bonds broadly lagged stock returns on a full year basis. However, these positive decisions were more than offset by investments in emerging market equities and a defensive position to shorter-duration mortgages. In part, emerging market equities were weighed down by disappointments regarding an anticipated recovery in China while mortgages had lower returns than riskier assets following the fourth quarter’s robust equity rally. It is important to recall, though, that mortgages can protect capital in downside scenarios (such as in the third quarter of 2023) while providing us with the flexibility to take advantage of tactical opportunities.

Recent Developments

The initiatives put forth by the central banks to curb inflation, combined with recent signaling that rate cuts would be included in their outlook for 2024, were well received by the market. This shift in policy led bond yields sharply lower and supported risk-taking, including equities. However, with inflation still ahead of target, coupled with resilient consumer spending, there remains a risk that the market is being overly optimistic and that rates may stay higher for longer, which has investors resetting their expectations. Additionally, growing global geo-political instability, along with tensions escalating in other areas, and elections taking place in seven of the world’s most populous countries this year, all provides further grounds for caution.

Looking ahead, the portfolio adviser believes investors should continue to expect a choppy environment throughout 2024 given

data-dependent monetary policy, high expectations for corporate earnings and political uncertainty. Against this backdrop, the portfolio adviser retains a cautious stance, with larger than Benchmark positions in mortgages aimed at protecting capital in potential downside scenarios while providing flexibility to take advantage of opportunities as they arise.

Over 2023, the portfolio adviser also increased their allocation to core Canadian bonds given that bonds are solid diversifiers for portfolios and have the potential to outperform in the event of a recession. In addition, although the portfolio adviser has a neutral allocation overall to equities, they continue to hold a small overweight position in Canadian equities due to their lower valuations and cyclical exposures, which will help the Portfolio to keep up with markets if upside scenarios play out.

Related Party Transactions

Pursuant to the Fund's investment strategies included in the Fund's Simplified Prospectus, the Fund may invest in other mutual funds and for the period has invested in various HSBC Funds which are funds managed by the Fund's Portfolio Adviser. Please refer to the "Top Holdings" in the Summary of Investment Portfolio section of this report.

In 2023 Educators Financial Group did not refer any conflict of interest matters to the Fund's Independent Review Committee (the IRC) and accordingly, did not rely upon any recommendation of the IRC in respect of any related party transactions.

Educators Financial Group is the Manager and Trustee of the Fund. Educators Financial Group is a wholly owned subsidiary of the Ontario Secondary School Teachers' Federation (OSSTF). OSSTF may from time to time invest in units of the Fund.

⁽⁷⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁸⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.



Management Fees

Educators Financial Group is the Manager-Trustee, promoter, and principal distributor of the Fund, and is responsible for the day-to-day management and administration of the Fund.

The Manager-Trustee monitors and evaluates the performance of the Fund and pays for the investment management services of the portfolio adviser, as well as all administrative services required by the Fund. As compensation for these services, Educators Financial Group is entitled to receive a fee, payable monthly and calculated daily, based on the Net Asset Value of the Fund, at the annual rate of 1.75% for the Class A Series, 1.40% for the Class E Series and 0.75% for the Class F Series. The Class I Series is identical in all aspects to the Class A Series, except that there is no management fee payable by the Fund in respect of the Class I units.

The Fund is responsible for paying any applicable tax owing on its management fee.

Approximately 12.0% of the total management fees collected from all Series (excluding Class I Series approximately 11.7% of the total management fees collected), were used to pay for portfolio management services, with the remainder of the fees being allocated to custodial services, marketing, technology, and Manager-Trustee operating expenses.

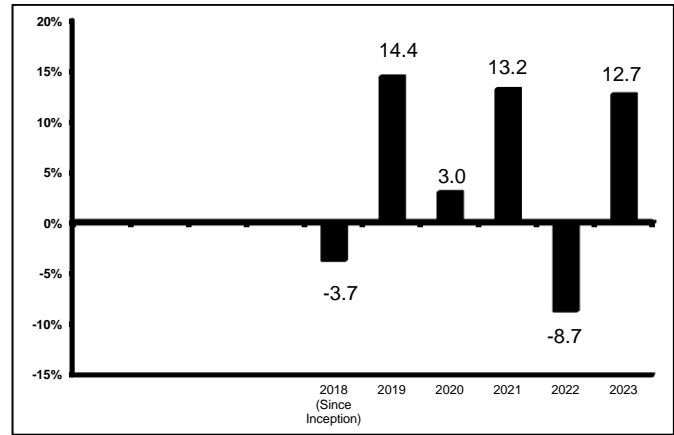

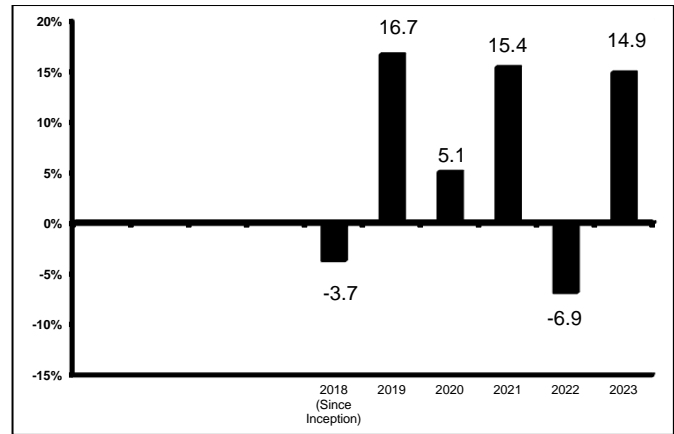
Year-by-Year Returns

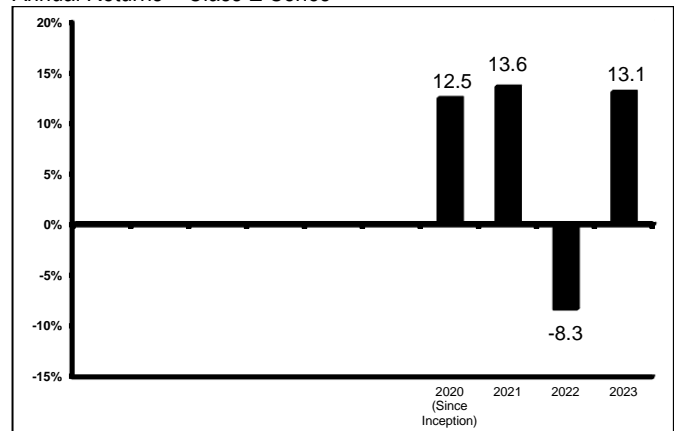
Annual Returns – Class A Series ⁽¹⁾



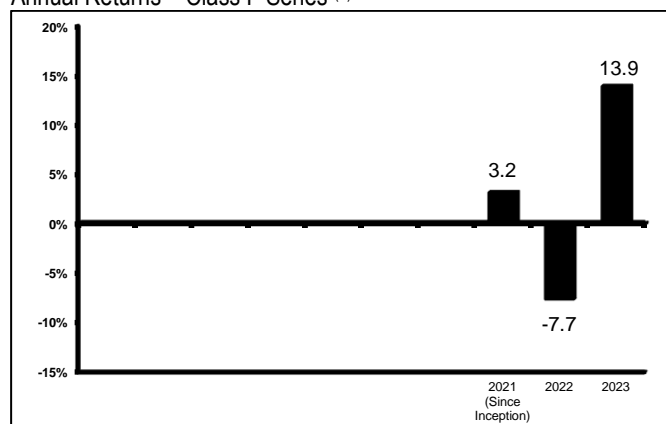
Annual Returns – Class I Series ⁽¹⁾

Annual Compound Returns

The following table compares the historical annual compound returns of the Fund with the performance of the blended Benchmark index comprised as follows: 20.0% MSCI EAFE Index C\$, a stock market index that is designed to measure the equity market performance of developed markets outside of the U.S. & Canada, 25.0% S&P 500 Index C\$, a stock market index based on the market capitalizations of 500 large companies having common stock listed on the New York Stock Exchange, 30.0% S&P/TSX Composite Index, a capitalization-weighted index designed to measure the market activity of some of the largest float adjusted stocks listed on the Toronto Stock Exchange, 22.5% FTSE Canada Universe Bond Index, which is a broad measure of the total return of Canadian bonds that mature in more than one year and 2.5% FTSE Canada Short Term Bond Index, a market capitalization-weighted index consisting of a broadly diversified range of investment grade federal, provincial, municipal and corporate bonds with a term to maturity between one and five years.
